Update to Viewing Multiple Documents

The “Documents are attached to this filing” interface has been updated for docket entries with multiple documents. Public users can specify which attachments to combine for viewing. Checkboxes were added to the far left of the documents attached to the docket entry. By default, the boxes will be checked. The user can de-select the box/es for the document/s that they do not want to view. They will only be billed for the documents they select to view and will receive a confirmation of billing charges before viewing the document/s selected.

Additionally, the number of pages and the total size of the selected documents will be updated in real time, just as they are on the Full Docket Report. If the user selects documents that have a combined file size exceeding the court-configured maximum file size, the “View Selected” button is disabled, and a message will display indicating that the documents exceed the court-configured size limit. Likewise, if the user selects documents that have a total page count exceeding the court-configured maximum page count, the “View Selected” button is disabled, and a message will display indicating that the documents exceed the court-configured page limit.
